6. Projected cash budget for first 6 months of post petition operations.
7. Detailed listing of Accounts Receivable and an Accounts Receivable Aging Report.
8. Bank Statements for all accounts for the 6 months prior to filing petition.
9. Report of Physical Inventory.
10. Current rent roll, if debtor has tenant-occupied property. Please include names of tenants and term of lease (or month to month)
11. Copies of current business licenses and performance bonds, if required.
12. Details on Pension, Welfare/Health Plans, (i.e., type of plans maintained, fully or self-insured, administrators, who makes contributions, who maintains assets of the plans).
13. Resume, job title, duties and responsibilities, salary/benefit package details for the Twelve months prior to filing and the anticipated salary/benefit package for each owner and/or officer.
